10 YEAR LIFE-

Furniture & Fixtures, Office or Store Equipment, Data Equipment, Electronics and Machinery & Equipment Heavy/ Manufacturing Trucks, Trucks, Trailers and Buses

Any Type of office furniture, retail fixtures, restaurant equipment, apartment and hotel goods and similar property. Building/contractor small equipment, automotive industry tools, communication equipment, fast food equipment and electric powered office machines. Telephone systems, fax machines, copy machines, point of sale equipment, and alarm systems. Heavy equipment, manufacturing, and processing equipment. Trucks and Trailers with apportioned tags may require a special form that you may acquire at the appraisal district for additional deduction.

5 YEAR LIFE-

Computers

Mainframe computers, personal computers, and word processors.

6 YEAR LIFE-

Passenger Vehicles

List all owned vehicles used in the business. Vehicles disposed of after January 1 are taxable for the year and must be reported.
